



Gist of Proceedings of the 35th Annual General Meeting (Sixth AGM Post - IPO of the Company) of Aarvi Encon Ltd.

1. Date, time and venue of the Meeting:

The 35th Annual General Meeting (Sixth AGM Post IPO of the Company) was held on Saturday, September 23, 2023 via Video Conferencing (VC) or Other Audio Visual Means (OAVM).

The Meeting commenced at 11:00 A.M. and concluded at 11:45 A.M.

2. Proceedings in brief:
